BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

The Department of Public Works (DPW), through an approved Council budget motion, planned and designed a traffic circle for the intersection of Wishon Avenue and Cortland Avenue as a traffic calming measure. To help calm traffic through the neighborhood, the project proposes to reconstruct the roadway within the intersection and install raised concrete medians along Wishon Avenue, immediately south and north of the Cortland Avenue, to narrow the travel lanes and direct traffic around a proposed raised concrete traffic circle that will be constructed at the center of the intersection. Other improvements include pedestrian facilities at each leg of the intersection and striping and signage enhancements within the limits for the project.

These improvements will slow traffic, enhancing the safety of the corridor for residents,


