A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE PUBLIC WORKS DIRECTOR OR DESIGNEE TO SUBMIT ADDITIONAL GRANT APPLICATIONS TO THE CALIFORNIA DEPARTMENT OF TRANSPORTATIONS REGIONAL ACTIVE TRANSPORTATION PROGRAM CYCLE 7 CALL FOR PROJECTS THAT SUPPORT ACTIVE TRANSPORTATION TOTALING UP TO \$3 MILLION IN REQUESTS FOR FUNDING; AND AUTHORIZING THE EXECUTION OF GRANT APPLICATIONS AND GRANT AGREEMENT DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE

WHEREAS, the City of Fresno is an eligible applicant of the 2024 Regional Active Transportation Program (ATP) Cycle 7 grant program; and

WHEREAS, the Regional Active Transportation Program provides grant funding for eligible local agencies for the purpose of increasing the proportion of trips accomplished by biking and walking, increasing the safety and mobility of non-motorized users, advancing the active transportation efforts of regional agencies to achieve greenhouse gas reduction goals, enhancing public health, ensuring disadvantaged communities fully share in the benefits of the program, and providing a broad spectrum of projects to benefit many types of active transportation users; and

WHEREAS, the California Transportation Commission, California Department of Transportation, and Fresno Council of Governments administer the program and have requested applications from eligible agencies; and

WHEREAS, the Department of Public Works intends to submit one grant application for funding of the projects to support active transportation; and

3. Appoints and authorizes the director of Public Works or designee, and each of them as agents for the City of Fresno, to execute and submit all grant application related documents and execute grant related agreements, subject to prior approval as to form by the City Attorney's Office.

4. This resolution shall be effective upon final approval.
