**The findings of the Proposal Evaluation Committee are summarized as follows:**

The Proposal Evaluation Committee applied the Sourcewell RFP evaluation criteria and determined that all proposal responses met the scope and mandatory submittal requirements and were evaluated.

**Category 1: Structural Apparatus and Comprehensive Solutions**

Alexis Fire Equipment Company delivers an extensive selection of custom-built fire apparatus solutions. The company operates through a nationwide network of authorized dealers, offers 24/7 customer support, and maintains an in-house service department. Alexis Fire Equipment Company provides a comprehensive warranty program covering the entire lifespan of each apparatus. Flexible financing and leasing options are available, along with significant discounts from MSRP.

Custom Fire Apparatus manufactures custom fire apparatus and related specialized equipment. They are offering a wide variety of fire service vehicles including initial attack/wildland, pumpers, rescue, and mobile water supply/pumper tender firefighting apparatus. Through direct sales and dealer network, they are able to

provide products and services to the United States and Canada. Their price list includes many common options when customizing base model vehicles. Custom Fire Apparatus, Inc. offers a solid discount off list price.

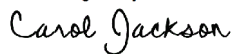
