A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, MAKING THE FOURTH AMENDMENT TO RESOLUTION NO. 2014-108 ENTITLED "A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO ESTABLISHING RULES FOR THE APPLICATION OF CITY EMPLOYEE COMPENSATION RATES AND SCHEDULES AND RELATED REQUIREMENTS, AND ESTABLISHING COMPENSATION RATES AND SCHEDULES FOR FY 2015"

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Fresno, as follows:

SECTION 1.

Exhibit 13.1, Unit 13, Management Non-Confidential Classes (CFPEA), is hereby amended to add the new classification of Senior Retirement Counselor and to provide a salary range for the respective class, retroactively effective May 18, 2015.

SECTION 2.

Exhibit 13.2, Unit 13, Non-Management Confidential Classes (CFPEA), is hereby amended to add the classification of Grant Writer and to provide a salary range for the respective class, retroactively effective May 18, 2015.

SECTION 3.

Exhibit 14 - Unit 14, Management Confidential Classes (CFMEA), is hereby amended to modify the Building & Safety Services Manager classification title; and add the Business Manager, Deputy City Engineer, Personnel Manager, Projects Administrator, and Senior Management Analyst classifications; and to provide new salary ranges for the respective classes in said Exhibit 14, pursuant to the results of the classification and compensation study required by the Memorandum of Understanding between the City and CFMEA, retroactively effective May 18, 2015.

SECTION 4.

Upon final legislative approval, this Resolution shall become retroactively effective on May 18, 2015.

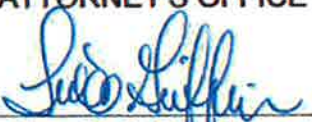
