ASSESSMENT BALLOT**

This ballot is for the use of the property owner of the parcel or parcels identified below by Assessor Parcel Number (APN). The parcel or parcels are located within the Downtown Fresno Property and Business Improvement District (PBID) in the City of Fresno.

This ballot may be used to express either support for, or opposition to, the renewed assessment in the proposed renewed PBID. The assessment is described in the Engineer's Report found on page 13 of the Management District Plan. The Management District Plan is on file and available for inspection with the City Clerk. To be counted, this ballot must be completed and signed below by an owner of the identified parcel or, if the owner is not an individual, by an authorized representative of the owner. The ballot must then be returned by mail or in person to the City Clerk at 2600 Fresno Street, Fresno, CA 93721.

**Delivery by Mail:** Seal the ballot in the envelope provided, affix first-class postage, and place in the mail so that it is received no later than the close of the public hearing on June 18, 2015 scheduled to begin at 1:30 p.m.

**Personal Delivery:** Seal the ballot in the envelope provided. Then deliver the sealed envelope to the City Clerk by the close of the public hearing to be held at 1:30 a.m. on June 18, 2015 in the City Council Chambers, 2600 Fresno Street, Fresno, CA 93721.

The City Council will not impose the assessment if the ballots submitted in opposition to the assessment exceed those submitted in favor of it. Each ballot is weighted according to the proportional financial obligation of the affected property.
