The high concentration of respiratory illnesses in our low income communities made worse by the worst air quality in the nation is an indication that the funding of parks must be made a higher priority by our City. It should no longer be acceptable that Fresno ranks at the bottom of national park surveys because of its limited availability of public parks for its residents.
