Jim has also created scholarships through their Foundation to help students with disabilities achieve their dreams by continuing their education after high school and become self-sufficient. He has provided these students with needed scholarships if they have a disability or even if they come from a family that has other members with disabilities. He feels that by doing this he is helping them create a "better tomorrow" for all of us.

Dear Selection Committee,

It is with great pleasure I nominate Mr. Jim Briscoe for the "City of Fresno Disability Advisory Commission's 2015 Achievement Award" in recognition for his tireless efforts in improving the quality of life and customer service to individuals with disabilities.

Jim Briscoe, married in 1983 to Lee Anne, moved to Fresno the same year to purchase a 25 year old steel distribution business, Valley Iron Inc. He has two sons actively involved in the business and 4 grandchildren, ages 5-17, that he hopes will become part of the business in the future. He started with 7 employees in 1983, and today has over 100 employees working with him in Fresno and a second location in Northern California. Valley Iron Inc. distributes un-fabricated Carbon Steel, Stainless Steel, and Aluminum products from Bakersfield to cities north of Sacramento and also throughout the Central Coast, including the Bay Area. In 2010 they established the Briscoe Family Charitable Foundation to give back to the communities that have supported their family and business for so many years. Prior to 2010, one individual in particular, either consciously or subconsciously, provided inspiration to Jim and members of his family to help individuals with disabilities to "give back to others and change lives within their community". This is when Jim met Daniel Delgado, a person with a disability who often came to Valley Iron to request material for projects for other people with disabilities. Mr. Briscoe did not hesitate to provide Daniel and others un-fabricated materials so that he could help individuals that needed items such as refurbished wheel chairs, accessible ramps for their houses, lifts for their vans so that they could transfer from their wheel chair into their vans, and so much more. Over the years, Jim has unselfishly given products to Daniel, who had polio as a child and uses a wheelchair himself, so that he could continue his work in providing other persons with disabilities, who have limited financial resources, the opportunity to receive desperately needed mobility products. Jim's giving nature through Daniel has had major impact on improving the quality of life for so many persons with disabilities. Jim has said that it has been a privilege and honor to support Daniel and others to receive whatever material they need at no cost so that they can do good work for other persons with disabilities. Helping individuals with disabilities receive what they need to become independent has been a passion for Jim.

Jim has also created scholarships through their Foundation prior to and certainly since 2010, which have helped many students with disabilities achieve their dreams so that they could continue their education after high school and become self- sufficient. He has provided these students with needed

scholarships if they have a disability or even if they come from a family that has other members with disabilities. He feels that by doing this he is helping them create a "better tomorrow" for all of us. Jim has felt that disabilities often come about at most inopportune time. A few years ago he helped to provide funds needed to build "Terry's House" at Community Hospital, which is a place for families to stay at night and support a loved one, if that individual is facing an extended stay in the hospital. He discovered that often a person recovering from an accident, stroke, serious illness and/or members of their families may acquire some a disability due to the stressful situation, yet do not have adequate financial or emotional support. He has been proud to be able to provide funds for Terry's House" to comfort these families during this very stressful time.

Jim believes that challenges in life and a potential disability are not always physical. Losing a child at birth or soon after is very heartbreakng for a mom and/or a new dad. What is staggering is how the efforts of one person, one particular person can truly make a difference in addressing this problem. He has thus supported the Hinds Hospice "Angel Babies" walk/run for a number of years and has been the major sponsor of the "Angel Babies Time to Remember" each fall. He feels that it is so important that these families know they can and should have loving memories of a child lost at birth and that there is help thru their journey of grief.

In addition to all the above, Jim has been deeply committed and involved with the State Center Community College Foundation, where his generosity has touched our 5,000 students with disabilities reach their maximum achievements and goals. He has given his commitment to help support additional needs of these students in the future. He says that his family is thankful that they have been blessed and are able to give back, support, and include in their giving, even in a small way, individuals with disabilities, who are working to meet every challenge that "life sends their way". He shared with me a favorite quote by Macklemore, a musician, wrote: "I don't control life – but I can control how I react to it". When speaking to him regarding this nomination, he quickly gave Daniel Delgado credit as one of the best examples he had met of how you can react to a disability in a most positive way! Jim Briscoe shares that he is proud to follow Daniel's lead and support his work and that of others with disabilities on their journey to success. Because of all these efforts, Jim Briscoe has not only earned my respect but gratitude of those individuals with disabilities for whom he has generously supported and thus I proudly nominate him for this award.


