RECOMMENDATION

It is recommended that the City Council adopt the 42nd Amendment to the Annual Appropriations Resolution (AAR) No. 2023-185 Appropriating \$100,000 in Women’s Recovery Grant Funding in FY 2024 for the City of Fresno Women’s Commission.

EXECUTIVE SUMMARY

The City of Fresno has been awarded grant funds of \$100,000 from the California Commission on the Status of Women and Girls (CCSWG) as part of their Women’s Recovery Grant Program. This AAR is needed to allow the Women’s Commission to utilize these funds in 2024.

BACKGROUND

The CCSWG administers California’s Women’s Recovery Grant Program first created in FY22 to address women’s economic recovery from the COVID-19 pandemic. During FY22, the City of Fresno applied for and received a \$25,000 capacity building grant that was utilized by the Women’s Commission to provide funds for 17, \$500 scholarships awarded to women pursuing a higher education in the City of Fresno, funded \$500 stipends for the 7 appointed commissioners, and provided funds for a boards and commission training program for appointed commissioners that included 6 sessions.

The Commission has been awarded a second award of \$100,000 from the second round of the Women’s Recovery Grant Program. This item will allow them to use these funds for implementation of a Fresno Women’s Scholarship Program and a Fresno Women’s Hygiene Program.
