## FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into as of this 1st day of July, 2021, amends the Agreement heretofore entered into between the City of Fresno, a municipal corporation (City), and Poverello House, a California Corporation (Consultant).

## **RECITALS**

WHEREAS, City and Consultant entered into an Agreement, dated September 1, 2019, for homeless family services for the Homeless Emergency Aid Program (HEAP) (Agreement); and

WHEREAS, City and Consultant desire to enter into this First Amendment to modify the Agreement to extend the contract term to December 31, 2023, and increase funding by \$148,078.37 using Homeless Housing, Assistance, and Prevention (HHAP) program funds for a total award of \$266,541.87.

## **AGREEMENT**

NOW, THEREFORE, the parties agree that the Agreement be amended as follows:

- 1. The term of the Agreement shall be extended to December 31, 2023.
- 2. The Consultant's sole compensation for satisfactory performance of all services required or rendered pursuant to the Agreement shall be increased by \$148,078.37 for a total fee of \$266,541.87.
- 3. Consultant's additional funding in the amount of \$148,078.37 shall be paid using HHAP funds.
- 4. In the event of any conflict between the body of this Amendment and the Agreement, the terms and conditions of the body of this Amendment shall control and take precedence over the terms and conditions expressed within the Agreement. Furthermore, any terms or conditions contained within the Agreement which purport to modify the allocation of risk between the parties, provided for within the body of this Amendment, shall be null and void.
