A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ADOPTING THE FY 2015-2016 ANNUAL ACTION PLAN; APPROVING SUBMISSION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR APPLICATION OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), HOME INVESTMENT PARTNERSHIPS (HOME), EMERGENCY SOLUTIONS GRANT (ESG), AND HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (HOPWA) PROGRAM FUNDS; AND AUTHORIZING THE CITY MANAGER TO SIGN ALL IMPLEMENTING DOCUMENTS REQUIRED BY HUD AS APPROVED TO FORM BY THE CITY ATTORNEY

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires all jurisdictions that receive federal entitlement funds to prepare an Annual Action Plan, which identifies the projects to be funded with Community Development Block Grant (CDBG), Home Investment Partnerships (HOME), Emergency Solutions Grant (ESG), and the Housing Opportunities for Persons with AIDS (HOPWA) Program funds; and

WHEREAS, in FY 2015-2016, the City of Fresno (City) is expected to receive over \$8.8 million from these funding sources; and

WHEREAS, the City has prepared a FY 2015-2016 Annual Action Plan, consistent with the five year Consolidated Plan which the City Council adopted on June 11, 2015, and consistent with the budget as detailed by the City of Fresno Proposed FY 2015-2016 Budget; and

WHEREAS, the thirty-day public review and comment period concludes June 3, 2015; and

WHEREAS, the City desires to submit its FY 2015-2016 Annual Action Plan to HUD to reflect changes made by the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FRESNO AS FOLLOWS:

1. The above recitals are true and correct and incorporated herein.
2. The Council of the City of Fresno, California, approves submission of the FY 2015-2016 Annual Action Plan to HUD to reflect changes made by the City Council to the adopted FY 2016 City of Fresno program entitlement budgets.
3. The City Manager is authorized to sign all reasonably required/implicated documents, instruments and funding agreements in pursuit hereof, subject to prior approval as to form by the City Attorney's Office.
