A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, APPROVING ALLOCATIONS AND AWARDING SUBRECIPIENT AGREEMENTS IN ACCORDANCE WITH THE 2020-2021 ANNUAL ACTION PLAN TO INCLUDE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS OF: \$1,028,001 FOR HOUSING REHABILITATION, \$161,000 FOR NON-PROFIT PUBLIC SERVICES, AND \$35,000 FOR MICRO-ENTERPRISE ASSISTANCE; HOME INVESTMENT PARTNERSHIPS FUNDS OF \$711,789 FOR TENANT-BASED RENTAL ASSISTANCE; EMERGENCY SOLUTIONS GRANT (ESG) FUNDS OF \$717,230 FOR HOMELESS AND HOMELESSNESS PREVENTION; AND HOUSING OPPORTUNITIES FOR PERSONS WITH HIV/AIDS (HOPWA) FUNDS OF \$617,040; AND AUTHORIZING THE CITY MANAGER TO SIGN ALL IMPLEMENTING DOCUMENTS REQUIRED BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) AS APPROVED TO FORM BY THE CITY ATTORNEY

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires all jurisdictions that receive federal entitlement funds to prepare an Annual Action Plan, which identifies the projects to be funded with Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), Emergency Solutions Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA) Program funds; and

WHEREAS, the Council of the City of Fresno adopted the 2020-2021 Annual Action Plan on May 21, 2020; and

WHEREAS, the City conducted a Consolidated Notice of Funding Availability (NOFA) process to identify qualified activities to meet the project objectives as outlined in the 2020-2021 Annual Action Plan for Housing Rehabilitation, Tenant-Based Rental

Assistance, Non-Profit Public Services, Emergency Solutions Grant, Housing Opportunities for Persons with HIV/AIDS, and Micro-Enterprise Assistance; and

WHEREAS, Staff reviewed the applications for eligibility and scored the applications according to the criteria described in the NOFA and thereafter an ad hoc committee of the City Council prepared a recommendation of applications and corresponding funding levels for approval as set forth in Exhibit "A"; and

WHEREAS, the City desires to enter into subrecipient agreements with applicants to provide Housing Rehabilitation, Homeless and Homelessness Prevention, and Public Services in the amounts reflected in Exhibit "A".
