A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE DIRECTOR OF PUBLIC UTILITIES OR DESIGNEE(S) TO PREPARE AND SUBMIT GRANT APPLICATIONS, ACCEPT FUNDS, AND EXECUTE ANY FINANCIAL ASSISTANCE AGREEMENTS AND AMENDMENTS WITH THE CALIFORNIA STATE WATER RESOURCES CONTROL BOARD ON BEHALF OF THE CITY OF FRESNO FOR THE PLANNING OF SEWER INFRASTRUCTURE TO SERVE THE COMMUNITY OF BRITTEN AVENUE

WHEREAS, the community of Britten Avenue (Community), located on Britten Avenue, east of South Cherry Avenue, is identified as a Disadvantaged Community (DAC) per State Water Resources Control Board (SWRCB) Division of Financial Assistance criteria; and

WHEREAS, the Community is presently relying upon individual septic systems and leach fields for sewage disposal; and

WHEREAS, water quality samples collected from the taps at three homes in the Community contained nitrate and/or uranium levels meeting or exceeding the maximum contaminant level (MCL) for drinking water; and

WHEREAS, the source for the nitrate is likely residential septic tanks and fertilizer runoff from neighboring agricultural areas; and


WHEREAS, maintaining individual septic systems is also more costly per capita than connection to a regional sewer collection system; and

WHEREAS, the Community desires to connect to the City of Fresno (City) sewer system to reduce dependence on the residential septic systems due to the age and

condition of the existing septic systems, the high cost of maintenance, and likelihood of contamination to groundwater and nearby wells posed by continued reliance on septic; and

WHEREAS, the Community is located outside the City's sphere of influence; and

WHEREAS, pursuant to California Government Code section 56133(c), the Fresno Local Area Formation Commission (LAFCo) may authorize a city or special district to provide new or extended services outside of its jurisdictional boundaries and outside its sphere of influence to respond to an existing or impending threat to the health or safety of the public or residents of the affected territory if certain conditions are met; and

WHEREAS, on June 6, 2023, LAFCo issued Resolution OS-23-02 authorizing the City to extend domestic water and sanitary sewer services to the Community; and

WHEREAS, prior to connecting to the City's sewer system, the Community will enter into an Extra-territorial Service Agreement with the City; and

WHEREAS, SWRCB has funding available through its Clean Water State Revolving Fund (CWSRF) that prioritizes safe, clean water and wastewater treatment solutions for small, disadvantaged communities; and

WHEREAS, the Department of Public Utilities (DPU) intends to apply for funding through CWSRF to fund a planning study for the installation of sewer extensions to serve the Community; and

WHEREAS, the City will be working with Self-Help Enterprises, through a Technical Assistance Workplan, to perform the tasks of the planning study to determine project feasibility. The planning study includes design work, environmental review, and preparation of an application for construction funding; and

WHEREAS, the SWRCB requires that the governing body of the applicant submit a resolution designating an authorized representative or their designee(s) to prepare and submit applications, accept funds, and execute the financial assistance agreements and any amendments thereto; and

WHEREAS, on February 22, 2024, the Council adopted Resolution 2024-033 authorizing the Director of Public Utilities to prepare and submit applications, accept funds, and execute financial assistance agreements, and any amendments thereto with the SWRCB for the planning, design, and construction of water and sewer infrastructure to serve the Community; and

WHEREAS, the proposed water and sewer planning studies and construction projects were combined in Resolution 2024-033. However, these are separate and independent studies and projects so DPU will be pursuing these studies and construction projects separately and will be requesting approval to submit separate applications for grant funding; and

WHEREAS, Council adopted Resolution 2025-____ which repealed and replaced Resolution 2024-033; and WHEREAS, the SWRCB requires separate funding applications for the planning activities and the sewer infrastructure construction; and

WHEREAS, this resolution only requests authority to apply for funding for a planning study for the sewer infrastructure project. Should the City receive grant funding for the planning study, DPU intends to submit a funding application for construction grant funding after completion of the planning study.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council of the City of Fresno, California authorizes this resolution.
2. The Director of Public Utilities (Authorized Representative) or designees(s) is authorized to prepare and submit funding applications, accept funds, and execute the financial assistance agreements and any amendments thereto with the State Resources Control Board (SWRCB) on behalf of the City for the planning of sewer infrastructure to serve the Community of Britten Avenue.
3. The Authorized Representative or designee(s) is authorized and designated to provide assurances, certifications, and commitments required for the financial assistance application.
4. The Authorized Representative or designee(s) is designated to represent the City in carrying out the City's responsibilities under the financial assistance agreements, including certifying disbursement requests on behalf of the City and compliance with applicable state and federal laws.
5. Subject to the foregoing provisions, the City certifies it has legal authority to participate in the aforementioned financial assistance programs with the state and federal government.
6. Nothing in this resolution binds or obligates the City's general fund, taxing authority, or borrowing power.
7. This resolution shall be effective upon final approval.
