Currently, Metron Farnier LLC is the only supplier of these single jet water meters that can conform to the City of Fresno's requirements.

BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment): The Department of Public Utilities/Water Division maintains over 1,300 large meters, and consider the single jet water meter to be an extremely effective meter for the City of Fresno's water supply to track customer account consumption for a service. The meter is unaffected by sand and/or small debris, very accurate at both low and high-end flows, and does not require much maintenance. Over time, all meters eventually wear down, which diminishes the accuracy of the amount of water measured, thereby reducing the revenue collected. This contract would provide meters for replacements as well as for new connections to the water system. Currently, Metron Farnier LLC is the only supplier of these single jet water meters that can conform to the City of Fresno's requirements.
