- b) To speak during a Committee meeting, while attending remotely in the Zoom application, click on the icon labeled "Participants" at the bottom of the screen. Then select "RaiseHand" at the bottom of the Participants window. Your digital hand will now be raised. You will be asked to "unmute" when your name is called to speak. You will not be visible via video and there will be no opportunity to share your screen.

PUBLIC COMMENTS –

- a) Unless otherwise announced, all public speakers will be limited to 3 minutes.
- b) Those addressing the Committee must state their name for the record.
- c) To facilitate electronic access, no person shall speak until recognized by the Chair.
- d) All participants will be on mute until called upon at which point they will be asked to unmute.
