A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ADOPTING THE 2023-2024 ANNUAL ACTION PLAN; APPROVING SUBMISSION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR APPLICATION OF \$6,897,161 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), \$3,578,083 HOME INVESTMENT PARTNERSHIPS (HOME), \$601,082 EMERGENCY SOLUTIONS GRANT (ESG), AND \$990,192 HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS/HIV (HOPWA) PROGRAM FUNDS; PROVIDING FOR SUBRECIPIENT AGREEMENTS; AND AUTHORIZING THE CITY MANAGER TO SIGN ALL IMPLEMENTING DOCUMENTS REQUIRED BY HUD AS APPROVED TO FORM BY THE CITY ATTORNEY

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires all jurisdictions that receive federal entitlement funds to prepare an Annual Action Plan, which identifies the projects to be funded with Community Development Block Grant (CDBG), Home Investment Partnerships (HOME), Emergency Solutions Grant (ESG), and the Housing Opportunities for Persons with AIDS (HOPWA) Program funds; and

WHEREAS, in Fiscal Year (FY) 2024, the City of Fresno (City) is expected to receive over \$12 million from these funding sources; and

WHEREAS, the City conducted a Consolidated Notice of Funding Availability (NOFA) process to identify qualified activities to meet the project objectives as outlined in the 2023-2024 Annual Action Plan for Homeless and Homelessness Prevention, Public Services, Owner-Occupied Home Repair, Fair Housing Services, and Infrastructure Improvements; and

WHEREAS, Staff reviewed the applications for eligibility and scored the applications according to the criteria described in the NOFA and thereafter reviewed the funding recommendation with an ad hoc committee of the City Council; and

WHEREAS, the City has prepared the 2023-2024 Annual Action Plan, consistent with the five-year Consolidated Plan which the City Council adopted on May 21, 2020, through Resolution 2020-117; and

WHEREAS, the thirty-day Annual Action Plan public review and comment period concluded on April 6, 2023, with nine comments received; and

WHEREAS, the City desires to submit its 2023-2024 Annual Action Plan to HUD to reflect changes made by the City Council and thereafter enter into subrecipient agreements with applicants to provide Homeless and Homelessness Prevention, Public Services, Owner-Occupied Home Repair, Fair Housing Services, and Infrastructure Improvements in the amounts reflected in 2023-2024 Annual Action Plan (Exhibit "A").

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The above recitals are true, and, correct and incorporated herein.
2. The Council of the City of Fresno, California, approves submission of the 2023-2024 Annual Action Plan to HUD.
3. The Council of the City of Fresno, California, approves allocation of subrecipient funds per the 2023-2024 Annual Action Plan.
4. The City Manager is authorized to sign all reasonably required or implicated documents, instruments, and funding agreements, and subrecipient agreements in pursuit hereof, subject to prior approval as to form by the City Attorney's

Office.

5. This resolution shall be effective upon final approval.
