

Elm Avenue Rezone Project

Summary of Neighborhood Outreach

Neighborhood Meeting

On October 25th and 26th, 2023, a letter to property owners within 2,000 feet of the subject property (APNs: 328-211-43, 328-211-44, 328-211-45, 328-211-46, 328-211-47, 328-211-48, 328-211-49, 328-211-50, 328-90-25, 328-290-28, and 328-290-29) was sent notifying them of a Neighborhood Meeting to occur on November 6, 2023. Letters were also sent out to tenants and residents within 1,000 feet of the subject property. A total of 428 letters were sent out. The letter is attached as **Exhibit A**. The full address list is attached as **Exhibit B**.

The meeting was held in-person at West Fresno Elementary School cafeteria, which is within close proximity of the subject property. Prior to the meeting, PCE received one email and two phone calls. PCE left a voicemail back to the caller and received no call back. The second caller had a question about the rezone itself, but no real concerns. The email other was asking for a copy of the letter sent out. PCE emailed this as requested.

The Neighborhood Meeting held on November 6, 2023 began at 6:00 pm. Six representatives from Precision Civil Engineering attended the meeting, along with 2 other applicant representatives. A sign-in sheet was circulated, and an estimated 40 individuals were found to be present at the meeting (some individuals did not want to sign in).

The applicant team began the meeting with a quick welcome and introduction of the applicant team, and then gave a brief overview of the Project through an informal PowerPoint presentation. This presentation provided background information on where the property is located, the existing conditions, what a rezone is, and the new proposal/rezone being introduced (etc.). A copy of the presentation is Attached as **Exhibit C.**

After the presentation, PCE transitioned into small groups where one representative from PCE facilitated a discussion with 5-6 attendees at each group. The following question served as conversation starters:

- 1. What are your concerns about the project: environmental, physical, safety, neighborhood compatibility.
- 2. What do you propose to address these concerns.
- 3. What do you like/dislike about the proposed conditions of zoning.
- 4. What you would change were asked.

Many participants provided feedback and answers to these questions. The responses are summarized below. The meeting concluded at 7:00 pm. Participants were asked to leave their email address to receive a follow-up on the questions/concerns raised. The applicant team plans on responding and presenting those responses to the City.

Summary of questions, comments, and concerns brought up at the Neighborhood Meeting (a full list is provided as Exhibit D).

During the Neighborhood Meeting, PCE heard the following:

- What changes are coming with the rezoning?
- The location is not supported.
- What will happen when improvement/upgrades are requested?
- What type of pollution might be produced?
- What's the difference between light and heavy industrial?
- Size of the Project and its significance to the surrounding area.
- What is the point if the existing business can operate now?
- Noise/odor/waste/traffic?
- Give a counterplan for brownfield.
- Owners did not ask the community what they want for the space.
- Why don't landowners see what they can do with the existing zoning?

Ultimately, the residents in attendance were not in support of the proposed rezone. It was communicated that participants were upset about the possible effects of the rezone. PCE and the applicant team told participants that they would give the city responses to all concerns and questions. They were also advised that the rezone application was in the early stages and that they would have additional opportunities to voice their concerns at Planning Commission and City Council hearings.

Dear Neighbor,

You are receiving this letter because you own property or live on property that is within 1,000 feet of property whose owners are requesting a rezone, or you are an identified interested party. A rezone is a request to change the zoning designated on a piece of land. Zoning is a set of rules by which land may be developed or used.

The subject property is located at 2825-2949 South Elm Avenue, Fresno, CA 93706 (see attached location map). The property is currently fully built out with light industrial uses and the owners of the property would like to continue current operations. The property was rezoned in 2017 from Light Industrial to Neighborhood Mixed Use. The property owners would simply like to go back to this Light Industrial zone district to more accurately reflect current uses on the property. No development is proposed as part of this rezoning request.

We are holding a neighborhood meeting to provide information and receive feedback from nearby residents and property owners regarding the proposed rezone and plan amendment (described below).

Project Information

The Project encompasses 55.31 acres of land bounded by South Elm Avenue to the west, Annadale Avenue to the north, SR 41 to the east, and adjacent parcels and East North Avenue to the south. Site addresses include 2825, 2855, 2875, 2909, 2925, 2929, 2933, 2935, 2945, 2947, 2949 South Elm Avenue, Fresno, CA 93706. The project proposes to change the zoning and land use from Neighborhood Mixed Use (NMX) to Light Industrial (IL). No development is proposed.

In addition to the rezone, the project also includes a Plan Amendment application to amend the planned land use designated by the Fresno General Plan and the Southwest Fresno Specific Plan from the NMX planned land use to the IL planned land use.



Where is the Property in Question?

The property is located within the City of Fresno, West of the 41, South of Annadale Avenue and East of Elm Avenue (area outlined in red).

Health Care Facilities

Mid Valley Disposal

West Fresno Elementary School is west of the subject property.

The subject property consists of 11 parcels totaling approximately 55.31 acres.



Existing Conditions

The property is currently located in a Neighborhood Mixed Use Zone (NMX) district.

Located to the north, south and west of the property are light industrial uses, with industrial uses also to the east (east of 41).

Currently the property is occupied by numerous light industrial businesses.

What is the Request?

The project proposes to rezone the parcels from Neighborhood Mixed Use Zone (NMX) to its original designation of Industrial-Light (IL) in order to be more consistent with the current uses. In addition to the rezoning, the proposed project includes land use Plan in order for the land use designation to be consistent with the proposed amendments to the South-West Fresno Specific Plan (SWFSP) and General

Additionally in order to address concerns previously raised by the community about the rezone request, the property owners have agreed to adding conditions on the zoning that will restrict future uses.

What is a Rezone?

A rezone is a request to change the zoning designated on a piece of land.

Zoning is a set of rules by which land may be developed or used. For example, in land zoned for residential the development of commercial uses is restricted.

Rezoning changes the existing zoning to a new zoning designation.

Background

Through the early 2000s, the properties included a former dairy and environmental contamination

The properties were redeveloped as part of the City's 1999 "Elm Avenue Corridor Blight Removal, Streetscape and Business Attraction."

The City attracted the current landowners to redevelop the Elm Avenue Corridor between the early 2000s and 2016

2017 Rezone

Rezoned to NMX in 2017 as part of the SWSP

The current uses are not allowed in the NMX Zone District

NMX Zone District primarily contemplates higher-density housing mixed with local-serving commercial uses and offices.

Allowed uses include:

Multi-family residential

Various commercial uses, including automobile repairs and sale, banks, entertainment, hotels/motels, offices, maintenance and repair services, and retail sales

Limited other uses

Why is the NMX Zoning a Problem?

- Rezoned to NMX in 2017
- Landowner Impacts:
- Diminishes the ability to attract reputable, responsible, and well-capitalized tenants
- Undermines ability to sell; plummeting property value
- Undermines ability to obtain financing
- Non-use can result in loss of legal non-conforming status
- Regional Issues:
- Loss of Jobs to other states and regions
- Undermines the City's ability to compete with other jurisdictions
- Economic investment requires certainty and predictability

City Council Direction

- SDG and Mid-Valley Disposal were rezoned to IL on 10/13/2022
- With respect to the remaining ~60 acres:
- negotiate with community representatives regarding an overlay On 10/13/2022, the City Council asked these landowners to district
- Those negotiations were unsuccessful
- On 5/11/2023, the City Council gave direction to seek IL zoning (without the overlay district)

New Proposal

Landowners are seeking to rezone the remaining acres to Light Industrial

Landowners made to resolve the issues identified by the community. These commitments would be binding on future property owners as Although the overlay district negotiations were unsuccessful, the Landowners are asking the City to keep the commitments the conditions of zoning recorded against title to the property.

Binding Commitments that Would Encumber the Property

The binding commitments include:

Limits most new construction/expansion of footprint

Prohibitions on certain uses, such as more intensive manufacturing uses and recycling

Ensuring trucks would not pass by schools or through residential neighborhoods

Assessment of Environmental Impacts

- The City is preparing an environmental analysis that assesses the potential environmental impacts of the rezone request
- No changes in land use or operations are proposed or requested
- The proposal includes prohibitions on enlarging existing uses
- As before, it is anticipated the document will find no new significant environmental effects would occur
