

FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into as of _____, 2022, amends the Agreement entered into between the City of Fresno, a California municipal corporation (City), and Youth Leadership Institute, a California non-profit organization (Partner). The City and the Partner are collectively referred as the “Parties” in this Amendment.

RECITALS

WHEREAS, the Parties entered into an agreement dated June 11, 2020, for the Transform Fresno Community Engagement Plan Leadership Development component (Agreement), and

WHEREAS, as part of the Agreement, the Fresno Economic Opportunities Commission (EOC) was listed as one of Partner’s subcontractors in the scope of work attached to the Agreement as Exhibit S1;

WHEREAS, as of June 30, 2022, EOC will no longer be partnering with Fresno Street Saints and, as a result of this separation, Partner desires to amend the scope of work to discontinue partnership with EOC;

WHEREAS, Fresno Street Saints will be operating in partnership with HandsOn Central California; and

WHEREAS, the Parties desire to amend the original scope of work to reflect the appropriate subcontracting agency.

AMENDMENT

NOW, THEREFORE, the Parties agree that the Agreement is amended as follows:

1. Each and all of the foregoing recitals of background facts are incorporated herein by reference as though set forth herein verbatim.
2. All partnerships and/or subcontractor services identified throughout the original agreement naming EOC shall be replaced with HandsOn Central California and Fresno Street Saints.
3. This Amendment shall become part of and subject to the terms and conditions of the Agreement, which except as modified herein, remains unchanged and in full force and effect. However, to the extent that the terms and conditions expressly set forth in this Amendment conflict with the terms and conditions of the Agreement, the terms and conditions expressly set forth in this Amendment will prevail. Unless otherwise defined in this Amendment, capitalized terms used herein shall have the meanings assigned to such terms in the Agreement.
