A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, DELEGATING CONTRACTING AUTHORITY TO INDIVIDUAL COUNCILMEMBERS FOR CONTRACTS FUNDED WITH COUNCIL DISTRICT FUNDS AND RESCINDING AND REPLACING RESOLUTION NO. 2017-67


WHEREAS, on March 9, 2017, the City Council adopted Resolution 2017-67, delegating contracting authority to individual councilmembers for contracts funded with council district funds, up to \$50,000; and

WHEREAS, it is in the best interest of the City of Fresno, to rescind Resolution 2017-67, to update the delegation of individual Councilmembers to enter into certain contracts; and

WHEREAS, pursuant to Fresno Municipal Code Section 4-107, Council may authorize by resolution an official or employee to contract for services, equipment, materials, supplies or public works construction for which competitive bidding is not required by the Charter; and

WHEREAS, Councilmembers frequently have a need to enter into such contracts funded from their Council budget; and

WHEREAS, Council now desires to formalize the delegation of authority to individual Councilmembers to enter into contracts where funding is coming from their Council district budget; and

WHEREAS, to meet the demands of market inflation, contracting authority to individual councilmembers for contracts funded with council district funds must be increased.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Resolution 2017-67 is rescinded in its entirety.
2. Councilmembers are authorized to individually enter into contracts where funding is coming solely from their Council district budget, up to \$100,000.
3. The Purchasing Manager shall assist as necessary with purchases made pursuant to this resolution.
4. This resolution shall be effective upon final approval.
