A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE PUBLIC WORKS DIRECTOR OR DESIGNEE TO NEGOTIATE AND EXECUTE ALL RIGHT-OF-WAY ACQUISITION DOCUMENTS AND AGREEMENTS NECESSARY TO COMPLETE THE SHIELDS AVENUE BANKSIDE TRAIL PROJECT FROM FRESNO STREET TO FIRST STREET

WHEREAS, the City of Fresno (City) proposes to install a multi-purpose, bicycle and pedestrian trail along the northern bank of the Herndon Canal from Fresno Street to First Street, also known as the Shields Avenue Bankside Trail from Fresno Street to First Street (Project); and

WHEREAS, FID currently performs canal maintenance activities from the northern bank of the Herndon Canal from Fresno Street to First Street, which use will be eliminated as part of the Project; and

WHEREAS, to mitigate the loss of the use of the northern bank of the Herndon Canal for the purpose of FID canal maintenance activities the City, the City will provide maintenance access improvements on the south bank of the Herndon Canal as part of the Project; and

WHEREAS, The City desires to acquire necessary maintenance/access easement(s) from WWD, on behalf of FID, to provide necessary access to the southern bank of the Herndon Canal, and to provide an equipment loading, unloading and staging area during canal maintenance activities.
