A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, STAYING IMPLEMENTATION OF
CITY EMPLOYEE SECURITY PROTOCOLS DUE TO
CORONAVIRUS (COVID-19)

WHEREAS, in December 2019, an outbreak of respiratory illness due to a novel coronavirus (COVID-19) was first identified in China, and has now spread outside of China, impacting more than 75 countries, including the United States; and

WHEREAS, as of March 4, 2020, there are 53 confirmed cases of COVID-19 in California, including at least one confirmed case in Fresno County; and

WHEREAS, on March 4, Governor Newsom declared a State of Emergency in the State of California; and

WHEREAS, the Governor has asked that every level of government help slow the spread of the virus; and

WHEREAS, the City has a new security protocol scheduled to begin March 26, which will require screening of every City Hall employee, and could result in large groups of employees and members of the public waiting in a screening line together; and

WHEREAS, one public health strategy to aid in prevention of the spread of the virus is "social distancing," or taking measures to limit large groups of people coming together; and

WHEREAS, in the interest of public health, implementation of the City Hall employee security measures set forth in Ordinance No. 2020-04 and Resolution No. 2020-35 should be stayed as set forth herein.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Implementation of the security measures pertaining to City employees in Ordinance No. 2020-04 and Resolution No. 2020-35 shall be stayed until April 27, 2020. The City Manager shall have the authority to extend the stay so long as Governor Newsom's declared State of Emergency stays in effect.

2. This Resolution shall be effective immediately.
