A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, INITIATING A TEXT AMENDMENT TO THE ZONING ORDINANCE OF THE CITY OF FRESNO PURSUANT TO FRESNO MUNICIPAL CODE SECTION 15-5803-A(1) TO ESTABLISH ZONING AND USE REGULATIONS FOR CRV RECYCLING CENTERS WITHIN THE CITY OF FRESNO

WHEREAS, the City of Fresno (City) is always seeking ways to improve public safety and the quality of life within our neighborhoods; and

WHEREAS, the City and Council District Offices receive calls on a regular basis about CRV Recycling Centers; and

WHEREAS, Council District Offices have also received complaints about CRV Recycling Centers interfering with the quiet enjoyment of nearby residents, and transients "hanging out" as they become intoxicated and leaving their litter behind; and

WHEREAS, businesses located in the City have called to express concern about the negative impact CRV Recycling Centers have on them; and

WHEREAS, the Fresno Police Department has received over 260 calls for service at CRV Recycling Center locations within the City since June 1, 2016; and

WHEREAS, the City Council desires to formally address CRV Recycling Centers within the Zoning Ordinance and ensure that CRV Recycling Centers are located in areas where their use will be consistent with the existing uses in the underlying zone district.
