Dear Council President Arias and Councilmembers:

We, the undersigned organizations, religious institutions, and entities, appreciate the City's efforts and leadership thus far in enacting emergency orders and protective measures responding to residents' urgent needs resulting from COVID-19 impacts. While we can only hope this pandemic will soon pass, the unknown leaves thousands of Fresno City households in limbo and in immediate need of government support and intervention from the local to the federal level. As over three million Californians have already filed for unemployment, countless more are excluded ineligible to apply. Fresno residents, in particular, are especially vulnerable to adverse impacts of this pandemic when already faced with the challenges of housing instability with below-average median household incomes; a large undocumented population that is ineligible to receive public benefits; and a majority of households that are rent-burdened. To further protect the health, safety, and welfare of Fresno City residents, we urge the Council to support and pass ID 20-00493 with the following additional modifications:

- Align this order with the Judicial Council's rules and timeline adopted April 6, 2020. This will lessen the confusion of various dates, timelines, and general information that is being shared across various media outlets. Additionally, this alignment will also support Fresno Courts as they too prepare themselves for a post-COVID-19 reality.
- Modify section (g)(4) to allow tenants up to twelve months to repay back any rent. With an average rent of \$1,136 and an average salary of \$17.10 before taxes, the reality is that missing even 1 or 2 months of rent can drastically set a family back¹². With nearly a third of Fresno families living in poverty prior to the pandemic, we can only expect this number to increase drastically even after the state of emergency is lifted. Even once the state of emergency is lifted, it will be hard for countless families to repay their past-due rent within the six month time period. The unfortunate reality is that many will have to compete with dozens of other people for the same job, making it harder to find a job right away. A twelvemonth window to repay any missed rent will ensure landlords get paid what

they're owed and tenants can have reasonable payments, all while stabilizing Fresno's rental housing market and preventing evictions.

- Align section (g)(3) requiring a tenant to provide documentation to Governor Newsom's Executive Order N-37-20 or at least extend the timeframe to no less than thirty (30) days for a tenant to provide documentation. As religious institutions and organizations who have spent countless hours working with Fresno City tenants, it has come to our realization that despite the emergency protections and best efforts to inform tenants of their rights, many are still unaware or unsure of these measures. Alignment with the Governor's Emergency Order or offering a thirty-day time period will give tenants a chance to inform themselves of their rights and responsibilities, and obtain adequate documentation for their landlord. During an already stressful time when many businesses are slow to respond, many tenants will have difficulty obtaining documentation and will have added stress worsened by the short timeframe. An additional twenty-day extension in no way rids a tenant of their responsibility and continues to provide the landlord the documentation required.
- Modify section (i) in the Executive Order 2020-12 directing the City Manager to identify funds and create a COVID-19 Emergency Response Fund to include specific funding for a housing assistance program. Monies for this fund can and should be allocated from federal, state, and local dollars such as the federal stimulus approved last month. This specific funding will support tenants who will continue to struggle to catch up on their rent payments once the State of Emergency is lifted. With over half of the City's residents being renters, nearly 70% are rent-burdened, and many living paycheck to paycheck, losing their job or losing hours is a situation many will not be able to recover from. Having some sort of funding assistance, similar to the small-business loan program, will support tenants and facilitate the City's economy to rebound faster and stronger.
