A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, MODIFYING RESOLUTION NO.  
2015-49 RELATING TO THE MASTER EQUIPMENT  
LEASE AGREEMENT WITH COMMUNITY FIRST  
NATIONAL BANK

WHEREAS, the City adopted Resolution No. 2015-49 ("Resolution") authorizing the execution of the Master Equipment Lease-Purchase Agreement, dated April 1, 2015 (the "Lease"); and

WHEREAS, in order to acquire, purchase, and finance fire equipment, the City entered into the Lease, with Community First National Bank, as lessor; and

WHEREAS, the Resolution contained clerical errors and Community First National Bank requests a modification to the Resolution to list all equipment acquired, purchased and financed under the Lease.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Fresno as follows:

1. Council finds and determines the Resolution shall be modified to include:
  - (a) The Lease shall be used to acquire, purchase, and finance certain property consisting of: 1) One New Aerial Truck; 2) One Platform Truck; 3) Eight Fire Engines; 4) One Water Tender; 5) Eight Light vehicles; 6) Ten Thermal Imaging Cameras; 7) Eleven Mobile Data Terminals; 8) Hoses; 9) Radios; and 10) other equipment, on the terms provided in the Resolution; and
  - (b) The maximum term under any Lease entered into pursuant to the Lease shall not exceed ten (10) years.
