A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO DISPENSE WITH THE COMPETITIVE SOLICITATION REQUIREMENTS AND AUTHORIZE THE CITY MANAGER OR DESIGNEE TO ENTER INTO A CONTRACT FOR RECREATIONAL SERVICES WITH RIVER PARK LITTLE LEAGUE

WHEREAS, River Park Little League (League) is a nonprofit organization; and

WHEREAS, the League has successfully run sports leagues in Central California for a number of years and has a proven track record of running leagues, tournaments, and clinics at other City PARCS facilities; and

WHEREAS, the League proposes to offer services and programming at the Fresno Metropolitan Flood Control District basin adjacent to Kaiser park, Kaiser Park, and the "League of Dreams" field at Inspiration Park; and

WHEREAS, the League is chartered by Little League international to operate Challenger baseball and has the infrastructure, equipment, volunteers, and experience readily available and adjacent to handle the programs; and

WHEREAS, the Little League Challenger program allows youths with all ranges of disabilities to play baseball, and Inspiration Park was designed precisely for this type of program, allowing the field to be utilized as envisioned; and

WHEREAS, the League will offer spring and fall youth baseball, spring Challenger League baseball for youths with disabilities, and a baseball camp for the Challenger League.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Fresno finds as follows:

1. The foregoing recitals are incorporated into this Resolution by this reference, and constitute a material part of this Resolution.

2. The proven experience of the League, the charter with Little League International, and the nature of programming offered is unique to the League and could not be adequately provided by any other source.

3. If the City were to provide the services provided by the League, it would cost the City in excess of \$150,000, making the service contract a good value for the City.

4. It is, therefore, proper for the City to dispense with the competitive solicitation requirement in this instance because the League is uniquely qualified to provide the services required under this agreement.
