A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, DECLARING THE RESULTS OF
THE CONSOLIDATED DIRECT PRIMARY ELECTION

WHEREAS, on June 5, 2018, a primary election was held in the City of Fresno,
pursuant to Section 1400 of the Charter of the City of Fresno; and

follows:

1. The certified statement of votes cast heretofore presented to this Council
by the County Clerk of Fresno County is accepted and adopted as the official canvass
of the returns of the June 5, 2018, primary election held in the City of Fresno, and the
Council finds, determines, and declares the results of the returns of the election as
follows:
