REPORT FROM EVALUATION COMMITTEE REQUEST FOR PROPOSAL FOR WEEKLY LANDSCAPE MAINTENANCE SERVICES - RFP NO. 9273

BACKGROUND

The goal of this Request for Proposal (RFP) was to solicit proposals to provide professional weekly landscape maintenance services. The operator will be responsible for maintaining various areas through the City of Fresno on a weekly basis.

Proposals were submitted by the seven vendors according to the Request for Proposal August 26, 2014 deadline. Below is a summary of Proposals submitted by the seven vendors:

COMMITTEE NOTES

Evaluation committee members were in agreement that all six proposers are capable of providing the City of Fresno with professional landscape services. Therefore, the selection was based on the differences in the vendors' written proposals, and site visits.

In the first committee meeting Lincoln Training Center, FEOC, Evergreen and Mow-N-Edge were eliminated. Lincoln Training Center submitted the highest proposal. FEOC currently maintains a majority of the areas in this RFP, their proposal was found to be cost prohibitive as well. The committee

felt that Evergreen's proposal was weak; they did not include a list of equipment or an organizational chart. Mow-N-Edge turned in a proposal that was non-responsive; they did not include Addendum 4 which changed the whole bid proposal page. The committee narrowed down their selection to three viable candidates: All Commercial Landscape Services, Elite Maintenance & Tree Service Inc. and Jakusz based on their submitted proposals.

The three remaining proposers were asked to submit a list of locations that they currently service for the committee's inspection. The locations that were selected for inspection were sites that were comparable to the City of Fresno's sites that are listed in this RFP. A visiting team then went out to view the properties and take pictures that were later presented to the committee.

After the site visits and references were called, the evaluation committee met and reviewed the findings. Jakusz was eliminated; their financials were questionable; the committee didn't feel secure that Jakusz would be able to meet an increased work load. Pictures were presented from each of the final three proposer's work sites and discussed. Each member agreed that based on the site visits, pictures and submitted proposals, All Commercial Landscape Service and Elite Maintenance & Tree Service Inc. will provide the best value for the City of Fresno. The award will be split by quadrants with Elite being awarded the Northwest Quadrant and All Commercial Landscape Service the rest of the quadrants.

ALL COMMERCIAL LANDSCAPE SERVICE

The committee unanimously agreed that All Commercial Landscape Service will provide the best value to service the needs of the City of Fresno's landscape sites professionally for the Northeast, Southeast, and Downtown quadrants. This was reflected in their proposal, subsequent site visits, photos presented and references which focused on meeting each of the Weekly Landscape Maintenance Services RFP criteria for both commercial and roadside landscapes. Their references were checked and found to be satisfactory.

ELITE MAINTENANCE & TREE SERVICE INC.

The committee also unanimously agreed that Elite Maintenance & Tree Service Inc. will provide the best value to service the needs of the City of Fresno's landscape sites professionally for the northwest quadrant. This was reflected in their proposal, subsequent site visits and photos which focused on meeting each of the Weekly Landscape Maintenance Services RFP criteria for primarily roadside landscapes. Their references were checked and found to be satisfactory.

JAKUSZ

Jakusz has a lot of municipal experience but were eliminated at the second committee meeting. Their proposal was missing an organizational chart and list of equipment. Site visits were made and the results were not that of the City of Fresno standards. Some of the sites had weeds throughout the flower beds, uneven edging and trees that needed trimming. Their references were checked and found to be satisfactory.

LINCOLN TRAINING CENTER AND REHABILITATION WORKSHOP

Lincoln Training Center is headquarted in South El Monte, California. They have 19 years of experience in landscaping including experience in janitorial services. Their proposal had a great landscape maintenance service plan but most of their experience seems to be in the janitorial area. They didn't appear to have the ability to meet the demands required of the City of Fresno even though their proposal reflects that they met the RFP criteria. They submitted the highest cost proposal for this RFP.

EVERGREEN

Evergreen was eliminated at the first committee meeting. Their proposal lacked detail and was missing an organizational chart and list of equipment. Their cost proposal and spreadsheet were thousands of dollars apart. This made it difficult to pass them through to the next round.

FRESNO ECONOMIC OPPORTUNITIES COMMISSION

The FEOC has provided the City of Fresno with landscape maintenance service for 10+ years with their Local Conservation Corps (LCC) work crews. The committee felt that although the FEOC would definitely be able to perform the requirements of this RFP satisfactorily, their pricing was relatively high. The City of Fresno has had issues in the past with their work crews dealing with the general public, which was reported to the FEOC. Their references were checked and found to be satisfactory.

MOW-N-EDGE

Mow-N-Edge was found to be non-responsive because they failed to include Addendum 4 with their proposal. This changed the entire bid proposal page which made their proposal incomplete. Their submittal could not be evaluated.

RECOMMENDATION:

The committee unanimously agrees and reconfirms their findings that All Commercial Landscape Service and Elite Maintenance & Tree Service Inc. will be able to provide the most effective and efficient professional Weekly Landscape Maintenance Services as well as the best value based on their proposal and site visits. Therefore, the committee recommends that All Commercial Landscape Services and Elite Maintenance & Tree Service Inc. be awarded the Weekly Landscape Maintenance Services contract with Elite Maintenance & Tree Service Inc. maintaining the Northwest quadrant and All Commercial Landscape Service maintaining the remaining quadrants.
