A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, DECLARING A VACANCY IN THE OFFICE OF COUNCILMEMBER FOR DISTRICT FIVE; CALLING A SPECIAL ELECTION TO FILL THE VACANCY TO BE CONSOLIDATED WITH THE NOVEMBER 8, 2016 GENERAL ELECTION; AND CALLING FOR A POTENTIAL RUN-OFF ELECTION ON MARCH 7, 2017

WHEREAS, Councilmember Sal Quintero has served in the office of Councilmember for District Five; and

WHEREAS, Councilmember Quintero's term of office was set to expire on the first Tuesday after the first Monday in January of 2019; and

WHEREAS, Councilmember Quintero has been elected to the Fresno County Board of Supervisors and will take office January 3, 2017; and

WHEREAS, Councilmember Quintero has submitted his resignation to the City Clerk effective January 3, 2017 (attached as Exhibit "A"); and

WHEREAS, Section 305 of the Fresno City Charter requires the vacancy to be filled by special election.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Receipt of Councilmember Sal Quintero's letter of resignation by the City Clerk, effective January 3, 2017, is hereby acknowledged.

2. A vacancy is declared in the office of Councilmember for District Five effective January 3, 2017.

3. The Council hereby requests the election to fill the vacancy for the remaining term in the office of Councilmember for District Five be consolidated with the
