

**FIRST AMENDMENT TO
AGREEMENT**

THIS FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into effect the _____ day of _____, 2017, (Effective Date) amends the Agreement heretofore entered into between the CITY OF FRESNO, a California municipal corporation (City), and LIVE OAK ASSOCIATES, INC., a California corporation (Consultant).

RECITALS

WHEREAS, the City and the Consultant entered into an agreement on May 2, 2016, (Agreement) to provide professional Biological Resources Monitoring services for Friant Kern Canal Pipeline (Project) for a total fee of \$384,956; and

WHEREAS, the parties have negotiated an increase of \$191,000 in the Consultant's compensation for services related to Biological Resources Monitoring services; and

WHEREAS, the City and the Consultant desire to extend the Agreement to October 31, 2017, to complete services; and

WHEREAS, with entry into this Agreement, the Consultant agrees the Consultant has no claim, demand, or dispute against the City.

AGREEMENT

NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual promises herein conditioned, and for other good and valuable consideration hereby acknowledge, the parties agree that the aforesaid Agreement be amended as follows:

1. The Consultant's sole compensation for satisfactory performance of Biological Resources Monitoring services for the Project pursuant to this Amendment shall be \$191,000. Compensation includes all expenses incurred by the Consultant in performance of such services. Total Consultant Project cost pursuant to this Agreement is \$576,956.

2. The Agreement is extended to October 31, 2017.

3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on May 2, 2016, respectively, remains in full force and effect.
