The turf at Pilibos Park is in desperate need of repair/replacement. Upon further investigation into the park, it was determined that due to the scale of the park and the irrigation required, the old irrigation pump controller is unable to keep up with demands. The pump controller is out of date and when it requires servicing it can take months before it is back up and running, therefore causing all of the turf to die. Therefore, the PARCS Department desires to replace the irrigation pump controller and rehab/replant the turf at all four soccer fields.
