- WHEREAS, Sam Frank, born in Los Angeles, California, graduated from Santa Cruz High in 1982. Following his graduation, Sam served in the United States Army for four years, achieving the rank of Sergeant before receiving an honorable discharge. Seeking new opportunities, he relocated to Fresno during a period of growth and ample employment prospects; and
- WHEREAS, in 1990, he was employed by the City of Fresno as a Utility Service Representative (USR). His duties included managing water services and conducting property inspections for utilities. Recognized for his dedication, Sam received the Employee of the Quarter award three times. In 2005, after fifteen years as a USR, he was promoted to Senior Utility Service Representative. That same year, he married Josephine Frank, whose unwavering support has been pivotal throughout his career; and
- WHEREAS, before his promotion to Senior USR, Sam found his passion serving on the Fresno City
 Employees Association (FCEA). Assuming various leadership roles, he championed the rights of his fellow
 workers. From 1997 to 1999, he served as director for FCEA, followed by a term as president from 1999
 to 2002. Re-elected as president in 2018, Sam has remained committed to representing the interests of the
 union's employees; and
- WHEREAS, during this presidency, he helped endorse many candidates who later served on the Fresno City Council and continued to work with the City's Administration to secure contracts and get raises for the workers he represented. His goal was to always serve as a good representative and a hard negotiator; and
- WHEREAS, while serving as president in 2000, he spearheaded efforts to extend benefits to the domestic partners of City of Fresno employees, recognizing the need for inclusivity at a time when same-sex marriage was not legally recognized. Drawing from his relationships within the LGBTQ+ community, Sam initiated discussions with the administration and FCEA members, ultimately achieving success in expanding benefits to include domestic partners, and
- WHEREAS, upon retirement, Sam Frank intends to stay on with the Fresno City Employees Association as their business manager, dedicated to furthering the interests of the City of Fresno's workforce.
