- REVIEW CITY OF FRESNO DEVELOPMENT STANDARD FOR RECYCLING CENTER PERMITS
- COORDINATE WITH DEPARTMENT OF CALIFORNIA RESOURCES RECYCLING AND RECOVERY OFFICE TO MEET STATE RECYCLING CODES AND REDUCE NEIGHBORHOOD IMPACTS
