Various treatment processes at the Northeast Surface Water Treatment Facility (Facility) remove particulate matter from the raw water, which is directed to the Facility's sludge drying beds. Once particle settling occurs, the upper (clearer) waters are decanted and returned to the head of the facility for reprocessing. Once accumulated solids reach maximum levels, process waste streams are directed to another pond and the accumulated solids in the original pond are allowed to dry and are ultimately removed and taken to an approved landfill. The Facility's two northern ponds (Ponds 1 and 2) related to this award are earthen basins. The purpose of this project is to line Ponds 1 and 2 with concrete to reduce maintenance issues related to having earthen basins.
