A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, DIRECTING THE ADMINISTRATION TO PURSUE FUNDING TO COMPLETE THE VETERAN'S BOULEVARD PROJECT

WHEREAS, the Veteran's Boulevard Project (the Project) is an important road construction project in the City of Fresno, will provide crucial connectivity in west Fresno, and is especially impactful to the residents of Council District 2; and

WHEREAS, Veteran's Boulevard between Herndon and Shaw Avenues is fully funded and currently under construction; and

WHEREAS, the segment of Veteran's Boulevard between Shaw and Grantland Avenues remains unfunded; and

WHEREAS, it shall be the policy of the City of Fresno to complete the Project and complimentary connectivity projects intended to connect east and west Fresno across State Route 99 (including, but limited to, Shaw Avenue, Gettysburg Avenue, Ashlan Avenue, Shields Avenue, Clinton Avenue, McKinley Avenue, and Belmont Avenue), so that identifying and obtaining funding to complete the such projects is of the utmost importance.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:
