A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, ADOPTING A CONSTRUCTION  
IMPACT ASSISTANCE PROGRAM FOR THE FULTON  
MALL BUSINESSES AND PROPERTY OWNERS  
LOCATED WITHIN THE BOUNDARIES OF THE FULTON  
MALL RECONSTRUCTION PROJECT

WHEREAS, the City is expected to begin construction on the Fulton Mall Reconstruction Project in March 2016; and

WHEREAS, the City desires to minimize the impacts of construction on existing businesses and property owners; and

WHEREAS, the City and the Downtown Partnership have met with the owners of businesses and properties along the Fulton Mall and proposed a Construction Impact Assistance Program (“the Program”) as outlined in this resolution; and

WHEREAS, businesses and properties located along the Fulton Mall within the boundaries of Merced Mall, Mariposa Mall, Kern Mall, Federal Alley, Congo/Homerun Alley, and Inyo Street as depicted in Exhibit “A”, are eligible for the Program if they have paid all assessments due to the Downtown Fresno Property and Business Improvement District, and for properties with a basement encroaching into City right-of-way, have a signed Covenant & Permit (“Eligible Business and Property Owners”); and

WHEREAS, the incentives will be offered for a fourteen month period beginning on the date construction commences (“Construction Period”).

WHEREAS, the City will provide Eligible Businesses parking validation coupons, waiver of business tax and waiver or reduction of certain planning fees during the Construction Period.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Recitals above are incorporated by reference.
2. City shall provide the following incentives to Eligible Business and Property Owners during the Construction Period:
  - a. Parking validation coupons for up to two hours of free parking at Parking Garages 4, 7, 8 and 9 as depicted on Exhibit "A" to give to their customers (validation coupons are not valid during special events); and
  - b. Waiver of business license taxes due pursuant to Articles 10 and 12 of Chapter 7 of the Fresno Municipal Code; and
  - c. Waiver or reduction of certain planning fees as set forth in Exhibit "B".
3. This resolution shall take effect upon its adoption.

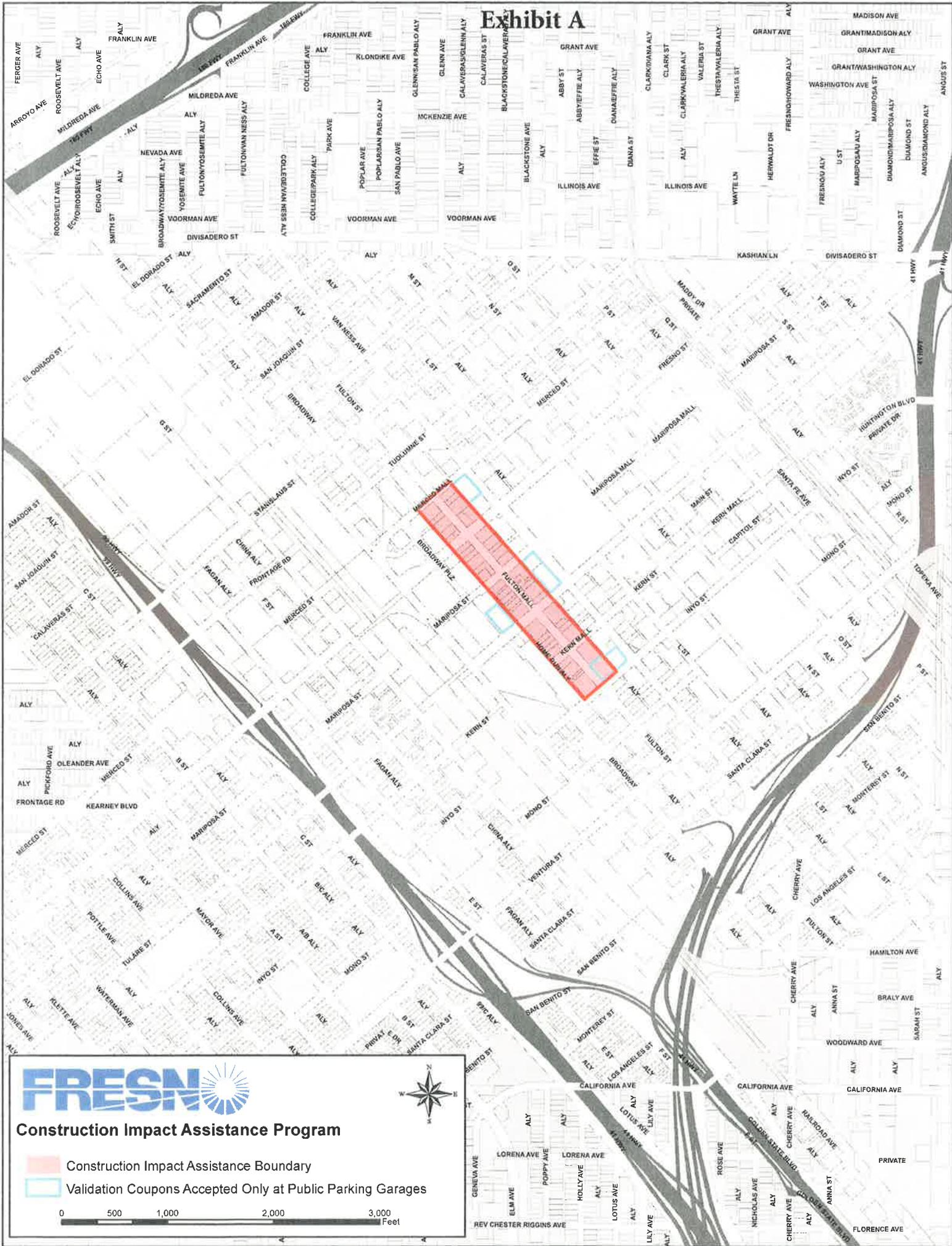
