PROJECT LOCATION: 6051 North Thesta Street; Located on the west side of North Thesta Street between East Bullard and East Escalon Avenues (APN: 409-200-43)

PROJECT DESCRIPTION: The project proposes acquisition of real property to facilitate development of an interim homeless shelter. Subject property is developed with an existing motel.

This project is exempt under Sections 15301/Class 1 and 15332/Class 32 of the California Environmental Quality Act (CEQA) Guidelines as follows:

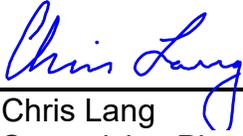
Under Section 15301/Class 1, the proposed project is exempt from CEQA requirements when the project consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use. Under Section 15332/Class 32, a project is exempt from CEQA requirements when characterized as in-fill development, which consists of the following: 1) The project is consistent with the applicable general plan designation and all applicable general plan policies as well as with applicable zoning designation and regulations; 2) The proposed development occurs within city limits on a project site of no more than five acres in size and substantially surrounded by urban uses; 3) The project site has no value as a habitat for endangered, rare or threatened species; 4) Approval of the project would not result in any significant effects relating to traffic, noise, air quality, or water quality; and, 5) The site can be adequately served by all required utilities and public services.

The project proposes acquisition of an existing motel for the purpose of converting the structure into an interim homeless shelter. The acquisition and conversion will result in a negligible expansion of the former use. No new construction is proposed, and improvements would be limited to repair, maintenance, and minor alterations which are otherwise necessary to comply with California Building Code. The project site is located on a one-acre parcel which is surrounded by urban uses, and has no value as a habitat for endangered, rare or threatened species. The project site is located adjacent to State Route 41 and is served by all necessary utilities and public services. None of the exceptions to Categorical Exemptions set forth in the CEQA Guidelines, Section 15300.2 apply to the project. Therefore, the proposed project is not expected to have a significant effect on the environment. A Categorical Exemption, as noted above, has been prepared for the project.
