All other proposals were found to meet the scope and mandatory submittal requirements and were evaluated.

They offer multiple software options to integrate their products with other manufacturer's products to assist in equipment standardization. Their direct sales and service staff is able to serve Sourcewell's United States and Canadian participating entities with service facilities in both countries. Aries is offering a considerable discount on all of their products.

Envirosight, LLC, offers an entire line of products for the inspection and repair of sewer and stormwater infrastructure. Their equipment is compatible with a variety of software packages and their software products are also compatible with multiple brands of hardware available in the industry. The Envirosight dealer network covers

the United States and Canada and to deliver sales and service to Sourcewell participating entities. They offer significant discounts across their product offering.

RapidView LLC is offering a wide line of sewer, water and industrial pipeline inspection and repair equipment, and ancillary accessories.
