ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF FRESNO, CALIFORNIA, REPEALING SECTION 7-1221, SECTION 7-1222, SECTION 7-1237, AND SECTION 7-1238, AND AMENDING SECTION 7-1233 OF THE FRESNO MUNICIPAL CODE, RELATING TO OUTDATED PROVISIONS CONCERNING VARIOUS BUSINESS LICENSES

WHEREAS, the City has identified certain businesses and/or professions specified in the Fresno Municipal Code which are outdated and/or no longer exist; and

WHEREAS, on February 1, 2024, the City Council adopted Resolution 2024-016 removing from or otherwise revising business license fees associated with these businesses in the Master Fee Schedule; and

WHEREAS, the City has determined it is appropriate to amend the Fresno Municipal Code to repeal or otherwise revise these outdated sections.

THE COUNCIL OF THE CITY OF FRESNO DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 7-1221 of Fresno Municipal Code is repealed.

SECTION 2. Section 7-1222 of Fresno Municipal Code is repealed.

SECTION 3. Section 7-1237 of Fresno Municipal Code is repealed.

SECTION 4. Section 7-1238 of Fresno Municipal Code is repealed.

SECTION 5. Section 7-1233 of Fresno Municipal Code is amended to read:

A bootblack [shoeshine] is defined as every person conducting, carrying on or managing the business of shining boots or shoes.
