RESOLUTION AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION TO THE STATE OF CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT AND ACCEPTANCE OF UP TO \$127,600 IN HOUSING-RELATED PARKS PROGRAM GRANT FUNDS AND DESIGNATION AND APPROVAL OF THE PARCS ASSISTANT DIRECTOR AS SIGNATORY FOR EXECUTION OF PROGRAM PARTICIPATION DOCUMENTS

Qualifying Park Project ("Project"): the City of Fresno's  
Dickey Playground Park

WHEREAS, the State of California, Department of Housing and Community Development (hereinafter referred to as "HCD") announced the release of a Notice of Funding Availability (NOFA) on November 16, 2016, under its Housing-Related Parks ("HRP") Program; and

WHEREAS, the City of Fresno, a California municipal corporation ("Applicant") desires to apply for an HRP Program grant of up to \$127,600 and submit the 2016 Designated Program Year Application Package released by the HCD for the HRP Program;

WHEREAS, HCD is authorized to approve funding allocations for the HRP Program, subject to the terms and conditions of the NOFA, Program Guidelines, Application Package, and Standard Agreement; and

WHEREAS, the procedures established by HCD require the Applicant to certify by resolution the approval of an application to HCD; and the authorization to execute the HRP Program Standard Agreement, amendments thereto and related Program documents.

NOW THEREFORE, IT IS RESOLVED by the Council of the City of Fresno as follows:

1. The forgoing recitals are true and correct and incorporated herein;
2. Council authorizes submission of a 2016 Designated Program Year Application Package to HCD of up to \$127,600 in response to the November 16, 2016, NOFA. If the application is approved, the Applicant is hereby authorized and directed to enter into, execute, and deliver a State of California Standard Agreement (Standard Agreement), and any and all other documents required or deemed necessary or appropriate to secure the HRP Program Grant from HCD, and all amendments thereto (collectively, the "HRP Grant Documents").
3. Council authorizes the acceptance of HRP funds contingent upon Program funds being available and consistent with Constitutional and local law requirements and this resolution and agrees that Applicant shall use funds for allowable capital assets in the manner presented in the application as approved by HCD and in accordance with the HRP NOFA, Program Guidelines and Application Package.
4. Council appoints and authorizes the PARCS Assistant Director or designee as an agent of the City of Fresno, to conduct all negotiations, execute and submit the HRP Program Application Package and the HRP Grant Documents as required by the HCD for participation in the HRP Program, subject to approval as to form by the City Attorney's Office.
