****The attendance fee is to be applied to all tickets sold for attendance to events hosted by Organizations or Individuals charging admission at Regional Sports Complex, Ted C. Wills, Romain, Holmes, Frank H. Ball, and Maxie L. Parks.

Fees collected from the attendance fee will go towards improvements at the reserved facility. The fee will be charged based on the proposed attendance fee that will be provided by organizations in the application and would be collected as follows:

60 or more days prior to event	20%	50% of reservation deposit + actual cost
