

FIRST AMENDMENT TO CONSULTANT SERVICES AGREEMENT

THIS FIRST AMENDMENT TO CONSULTANT SERVICES AGREEMENT (First Amendment) is effective as of June 30, 2020, and amends the Consultant Services Agreement, dated March 8, 2020, entered into between the City of Fresno, a municipal corporation (CITY), and Hinderliter, de Llamas and Associates (HdL Companies), a California corporation (CONSULTANT).

RECITALS

- A. CITY and CONSULTANT entered into a Consultant Services Agreement, dated March 8, 2020, (the Agreement), whereby CONSULTANT agreed to perform the services described therein, with the term of the Agreement expiring on June 30, 2020.
- B. In light of mutual delays by both parties related to the COVID-19 pandemic, CITY and CONSULTANT now desire to amend the Agreement to extend the term of the Agreement until December 31, 2020.

AGREEMENT

NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual promises herein contained, and for other good and valuable consideration hereby acknowledged, the parties agree that the aforesaid agreement be amended as follows:


1. Term. Section 2 of the Agreement is deleted in its entirety and replaced with the following:

Term of Agreement and Time for Performance. This Agreement shall be effective from the date set forth above (Effective Date) and shall continue in full force and effect through December 31, 2020, subject to any earlier termination in accordance with this Agreement. The services of CONSULTANT as described in **Exhibit A** are to commence upon the Effective Date and shall be completed in a sequence assuring expeditious completion, but in any event, all such services shall be completed prior to expiration of this Agreement and in accordance with any performance schedule set forth in **Exhibit A**.

2. Counterparts. This First Amendment may be executed in any number of counterparts, each of which shall be an original, but all of such counterparts shall together constitute one and the same instrument. Delivery of an executed counterpart of this First Amendment by facsimile or other electronic means shall be equally effective as delivery of a manually executed original counterpart of this First Amendment.
3. Effect of Amendment. Except as expressly modified by this First Amendment, the Agreement is hereby reaffirmed and ratified. In the event of any conflict between the Agreement and this First Amendment, this First Amendment shall control.


