A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO AUTHORIZE THE POLICE DEPARTMENT TO ACCEPT AN IN-KIND DONATION OF RETROFIT AT THE FRESNO POLICE DEPARTMENT'S GYMNASIUM FROM THE FRESNO POLICE OFFICERS ASSOCIATION IN EXCESS OF \$25,000 PURSUANT TO FRESNO MUNICIPAL CODE (FMC) SECTION 7-105, AND AUTHORIZE THE CITY MANAGER, OR DESIGNEE, TO EXECUTE ALL DOCUMENTS ON BEHALF OF THE CITY

WHEREAS, the City of Fresno has prioritized physical fitness and health as absolute top priorities for its sworn peace officers and staff; and

WHEREAS, the Fresno Police Officers' Association (FPOA) is a non-City of Fresno entity representing the nearly 1,000 officers and staff who serve the Fresno community at the Fresno Police Department (FPD);

WHEREAS, for more than 100 years, the FPOA members have served and protected the City of Fresno and its residents; and

WHEREAS, the National Institutes of Health, a part of the United States Department of Health and Human Services and the nation's medical research agency, has found that regular, vigorous law enforcement gym training is crucial for mitigating health risks, reducing job-related injury rates, and managing job-related stress; and

WHEREAS, the FPOA has generously indicated a desire to donate funds in excess of \$25,000 to the City of Fresno to upgrade and refit the FPD gym and training room.
