SECTION 3.

Exhibit 9, Unit 9, Police Management (FPOA), is hereby amended to provide salary increases for respective classes as required by the adoption of the successor Memorandum of Understanding between the City and Fresno Police Officers Association (Police Management– Unit 9), effective June 15, 2026.

SECTION 4.

Upon final legislative approval, this Resolution shall become effective July 28, 2025.
