A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO CALIFORNIA, **AUTHORIZING** THE DESIGNEE TO **NEGOTIATE** AN OR MANAGER AMENDMENT TO THE PROGRAM ELIGIBILITY AND FUNDING AGREEMENT, DATED DECEMBER 5, 2012, WITH THE **FRESNO** COUNTY TRANSPORTATION AUTHORITY RELATING TO THE REALLOCATION OF PROGRAM FUNDS TO THE MEASURE C TRANSIT DEVELOPMENT **PROGRAM** AND ORIENTED THE EXECUTION OF AMENDMENT AUTHORIZING RELATED DOCUMENTS BY THE CITY MANAGER OR **DESIGNEE**

WHEREAS, on August 23, 2012, the City of Fresno (the "City") adopted the Downtown Development Impact Fee Forgiveness Incentive Program ("DDIP");

WHEREAS, subsequently, the City entered into the Program Eligibility and Funding Agreement, dated December 5, 2012, with the Fresno County Transportation Authority ("FCTA") for the Downtown Development Impact Fee Forgiveness Program, which authorized the use of Measure C Transit Oriented Development ("TOD") funds to support the DDIP; and

WHEREAS, on December 17, 2015, the City Council of the City of Fresno adopted Ordinance No. 2015-44 relating to the exemption of development impact fees for certain projects in economically disadvantaged neighborhoods and Ordinance No. 2015-45 relating to the exemption of development impact fees for the replacement or reconstruction of existing commercial structures; and

WHEREAS, the adoption of Ordinance No. 2015-44 addresses the City's desire to incentivize development in Downtown Fresno in a way which coincides with the Measure C TOD Program Policy and Guidelines; and

WHEREAS, there is currently \$510,715 in unutilized funds remaining under the Program Eligibility and Funding Agreement; and

WHEREAS, the City would like to relinquish the funds encumbered under the DDIP back to the Measure C TOD Program for reallocation to support TOD eligible projects.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

SECTION 1. Authorize the City Manager or his designee to negotiate an Amendment to the Program Eligibility and Funding Agreement allowing the unspent DDIP funds to be reallocated to the Measure C TOD Program for eligible projects; and

SECTION 2. Appoints and authorizes the City Manager or his designee as the agent for the City of Fresno to execute and submit all amendment-related documents, materials and certifications necessary in pursuit hereof, subject to prior approval as to form by the City Attorney's Office.
