2. ***RESOLUTION – Adopting the 6th Amendment to the Annual Appropriations Resolution (AAR) No. 2023-185 appropriating \$50,000,000 for the Downtown Fresno Public Infrastructure Improvement Projects and to reclassify \$4,492,800 from the Department of Public Works and \$1,867,900 from the Department of Public Utilities into the new Capital Project Department (Requires 5 Affirmative Votes)(Subject to Mayor's Veto)

3. ***RESOLUTION – Adopt the First Amendment to the Position Authorization Resolution (PAR) No. 2023-184 adding 46 positions and transferring 74 positions from the Department of Public Works and 20 positions from the Department of Public Utilities to the Capital Projects Department (Subject to Mayor's Veto)

4. ***RESOLUTION – Adopt the First Amendment to the FY 2024 Salary Resolution No. 2023-183, amending Exhibit 13-1, Unit 13, Exempt Supervisory and Professional (CFPEA) by increasing the salary step plan for Supervising Professional Engineer and retitling Supervising Professional Engineer to Licensed Professional Engineer; and amending Exhibit 14, Unit 14, Exempt Management Classes (CFMEA) by retitling Public Works/Public Utilities Manager – Licensed Engineer to Licensed Engineer Manager and increasing the salary step range for the classification; and amending Exhibit 2, Non-Represented Management and Confidential Classes by increasing the Maximum of Range E5 (Subject to Mayor's Veto)

RECOMMENDATION

It is recommended that Council approve the actions pertaining to the creation of the Capital Projects Department within the City of Fresno effective July 31, 2023, to restructure efficiencies and timelines for the completion of critical City projects and to recruit and retain qualified staff.

EXECUTIVE SUMMARY

The creation of the Capital Projects Department will allow staff to focus on capital project delivery, restructure workflow efficiencies, and complete critical projects timely and within budget. The new department will guide hundreds of capital projects through the design, environmental, right-of-way and construction phases for parks, public safety facilities, street infrastructure, active transportation, wastewater and water system projects.

Adopting the 6th amendment to the AAR will appropriate \$50,000,000 for Downtown Fresno Infrastructure Improvement Projects; and reclassify \$4,492,800 from the Department of Public Works and \$1,867,900 from the Department of Public Utilities into the new Capital Projects Department. There will be no impact to the General Fund.

Adopting the First Amendment to the PAR will add 46 new positions, transfer 74 positions from the Department of Public Works and 20 positions from the Department of Public Utilities to the Capital Projects Department for a total of 140 positions.

Adopting the First Amendment to the Salary Resolution will allow the City to offer a competitive wage to aid in recruitment and retention efforts as follows.

- Amend Exhibit 13-1, Unit 13, Exempt Supervisory and Professional (CFPEA) by:
 - Increasing the monthly salary step plan range, Step A – Step E, for Supervising Professional Engineer and retitling to Licensed Professional Engineer, by approximately 15.32% from \$9,861- \$11,966 to \$11,353- \$13,800.
- Amend Exhibit 14, Unit 14, Management Classes (CFMEA) by:
 - Retitling the Public Works/Public Utilities Manager – Licensed Engineer to Licensed Engineer Manager.
 - Increasing the monthly salary step plan range, Step A – Step I, by approximately 14.53% from \$10,973 - \$13,366 to \$12,564 - \$15,308 monthly.
- Amend Exhibit 2, Unit 2, Non-Represented Management and Confidential Classes by:
 - Increasing the Maximum of the E5 range by 3.39% from \$15,546 to \$16,074 is necessary to recruit and retain qualified applicants at the Assistant Director level in the Capital Projects Department.

The City provided notice to the impacted bargaining units regarding the creation of the new Capital Projects Department.

The above actions will be effective 07/31/2023 and may be contingent upon completion of the meet and confer process.

To implement these actions, it is necessary to approve the creation of the Capital Projects Department; 6th Amendment to the AAR No. 2023-185; First Amendment to the PAR No. 2023-184; and First Amendment to FY 2024 Salary Resolution No. 2023-183.

BACKGROUND

1. Creating the Capital Projects Department within the City of Fresno

The City currently has hundreds of capital projects in process in the Department of Public Works (DPW) and the Department of Public Utilities (DPU) along with recently being awarded \$250 million from the State of California for infrastructure improvements to Downtown Fresno and \$80 million dedicated to the Blackstone and McKinley overlay project. Prioritizing capital projects along with other critical responsibilities that are integral to daily departmental operations and improvements to the general City infrastructure is of utmost importance and the City is building capacity to ensure

projects are delivered in a timely manner. The creation of the new Capital Projects Department is necessary to restructure the workflow of critical projects in focusing efficiencies on capital projects delivery, the completion of projects timely and within budget. The staff in this new department will be focused on critical capital projects delivery and will be comprised of existing City staff from DPW and DPU along with positions that are recommended to be added and transferred as outlined in the remaining action items of this report.

2. Adopting the 6th Amendment to the Annual Appropriations Resolution (AAR) No. 2023-185

The new Capital Projects Department will require appropriating \$50,000,000 for the Downtown Fresno Public Infrastructure Improvement Projects and reclassifying \$4,492,800 from the Department of Public Works and \$1,867,900 from the Department of Public Utilities to fund capital project costs, expenditures, equipment and staffing. There will be no impact to the General Fund.

3. Adopt the 1st amendment to the FY2024 Position Authorization Resolution (PAR) No. 2023-184

The creation of the new Capital Projects Department will include 94 transfer positions total from the Department of Public Works (74 positions) and the Department of Public Utilities (20 positions) in addition to 46 new positions for a total of 140 positions. Amending the PAR will allocate these positions to the Capital Projects Department and allow for developing the organizational structure to maximize project efficiencies.

4. Adopt the First Amendment to the FY 2024 Salary Resolution No. 2023-183

Amending Exhibit 13-1, Unit 13, Exempt Supervisory and Professional (CFPEA) by increasing the monthly salary step plan for Supervising Professional Engineer and retitling to Licensed Professional Engineer is necessary to recruit and retain qualified talent. The City has experienced challenges recruiting licensed Professional Engineers; the recommended salary increase will offer a competitive wage with other local and state agencies in recruiting Licensed Professional Engineers who are licensed and experienced in completing critical capital projects.

Amending Exhibit 14, Unit 14, Exempt Management Classes (CFMEA) by retitling Public Works/Public Utilities Manager – Licensed Engineer to Licensed Engineer Manager and increasing the monthly salary step range for the classification is necessary to recruit and retain qualified talent. Retitling the classification to Licensed Engineer Manager will emphasize the primary responsibility of this classification in managing operations and overseeing licensed Professional Engineers along with increasing the salary to appropriately address the focus of managing capital projects and licensed staff.

Amending Exhibit 2, Non-Represented Management and Confidential Classes by increasing the Maximum of Range E5 is necessary to retain qualified applicants at the Assistant Director level in the Capital Projects Department. Increasing the E5 Maximum of the salary range will offer flexibility in recruiting and retaining licensed Engineer staff at the Assistant Director level to maximize capital project objectives, project workflow, strategic planning and operational goals.

The City Attorney's Office has approved the creation of the new Capital Projects Department, 6th Amendment to the Annual Appropriations Resolution No. 2023-185, the First Amendment to the PAR No. 2023-184, and the First Amendment to Salary Resolution No. 2023-183, as to form.

ENVIRONMENTAL FINDINGS

By the definition provided in the California Environmental Quality Act Guidelines Section 15378 this item does not qualify as a “project” and is therefore exempt from the California Environmental Quality Act requirements.

LOCAL PREFERENCE

Local preference is not implicated because this item does not involve public contracting or bidding with the City of Fresno.

FISCAL IMPACT

Creating the new Capital Projects Department and adopting the 6th amendment to the AAR will include transferring existing appropriations from DPW in the amount of \$4,492,800; transferring existing appropriations from DPU in the amount of \$1,867,900; and allocating new funds in the amount of \$50,000,000 with no impact to the General Fund. Costs associated with amending Exhibit 13-1, Exhibit 14 and Exhibit 2 will not result in additional appropriations for the remaining FY 24.

A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, CREATING THE CAPITAL
PROJECTS DEPARTMENT

WHEREAS, the City of Fresno (City) is engaged in hundreds of capital projects annually, under the Department of Public Works; and

WHEREAS, the passage of Measure P and other developments have dramatically increased the number of capital projects currently underway within the City; and

WHEREAS, inadequate City staffing levels and insufficient salaries for certified professional engineers, have resulted in the timeline expectations of the Administration and Council not being met; and

WHEREAS; the City has recently be awarded hundreds of millions of dollars in forthcoming revenues to construct additional capital projects, including \$250,000,000 from the State of California for infrastructure improvements in Downtown Fresno and \$80,000,000 from the California State Transportation Agency for the Blackstone and McKinley grade separate project, which will greatly increase demands upon City staff; and

WHEREAS, to complete capital projects in a timely manner it is necessary to augment staffing and increase salary ranges for certified professional engineers, so that the City may successfully recruit and retain experienced staff; and

WHEREAS, for efficiency and expediency, it is desired that the delivery of capital projects be separated from the Public Works Department into a new distinct department; and

WHEREAS, Charter Section 801 provides: "The Council shall provide by resolution not inconsistent with this Charter...for the creation of departments, divisions, offices and agencies, and for their consolidation, alteration, or abolition."

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Consistent with Charter Section 801, the Capital Projects Department is hereby created.
2. Council hereby directs the Administration to take all actions necessary to implement this Resolution, including bringing forward the necessary budgetary, position authorization, and salary resolutions to implement this Resolution.
3. This Resolution shall be effective upon final approval.
