A. CALL TO ORDER

1) Annual Housing and Community Development Needs Public Hearing for Development of the Fiscal Year 2017-2018 Annual Action Plan

Director Clark provided an overview of the meeting and introduced the Deputy City Attorney, Raj Badhesha who reviewed the process for the Public Needs Hearing.

Mr. Thomas Morgan, Housing Manager, Housing and Community Development Division, introduced himself and began a presentation for the Community Needs Hearing titled Community Workshop and Conversation. Mr. Morgan explained the purpose of the meeting is to give an overview and encourage the public to provide input and help the City of Fresno with direction on how it will invest its FY 2017-2018 federal housing and community funds. The workshop is designed to provide the public with the opportunity to learn more about four HUD entitlement programs and how those funds might be used in the community. Mr. Morgan also reviewed the draft timeline for the Annual Action Plan.
