

FIRST AMENDMENT TO RECYCLING SERVICES AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into as of this ___ day of _____, 2019, amends the Services Agreement entered into between the CITY OF FRESNO, a municipal corporation (City), and Cedar Avenue Recycling and Transfer Station, LP, a California limited partnership (Contractor). This Amendment shall be effective commencing on _____, 2019.

RECITALS

WHEREAS, City and Contractor entered into a Services Agreement, dated July 1, 2016, for Co-Mingled Recyclables Processing services (Agreement);

WHEREAS, Section 6(e)(iv) of the Agreement sets forth that if average monthly market price is less than \$70 per ton for two consecutive quarters, Contractor may request a price adjustment and the City shall consider the request;

WHEREAS, Contractor has submitted such a request along with supporting documentation;

WHEREAS, upon consideration by the City, City and Contractor now agree to modify the Revenue Schedule for Recyclable Materials Payments set forth in Exhibit A of the Agreement.

AGREEMENT

NOW, THEREFORE, the Recitals above are incorporated herein as though set forth below, and the parties agree as follows:

1. The Revenue Schedule for Recyclable Materials Payments from Cedar Avenue Recycling and Transfer Station, LP, to City of Fresno, set forth in Exhibit A to the Agreement, shall be amended to read as follows:

2. If the average monthly market price is above \$130.00 for four consecutive quarters, a Rebate adjustment to Add-Back additional revenue, to be paid by Contractor to City, shall be added to Exhibit A as follows:

3. The above sections shall be based on the PPI Recovered Paper – Export market index, Mixed Paper (54) – OBM LA commodity designation.

4. All remaining terms of the Agreement remain in full force and effect.

5. This First Amendment shall remain effective through the term of the Agreement.
