A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE UNITED STATES DEPARTMENT OF TRANSPORTATION RECONNECTING COMMUNITIES PILOT GRANT PROGRAM CYCLE 3 CALL FOR PROJECTS TOTALING UP TO \$2 MILLION IN REQUEST FOR FUNDING; AND AUTHORIZING THE EXECUTION OF GRANT APPLICATION AND GRANT AGREEMENT DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE

WHEREAS, the Reconnecting Communities Pilot (RCP) Grant Program provides grant funds to eligible agencies for the purpose of reconnecting communities by removing, retrofitting, or mitigating highways or transportation facilities that create barriers to community connectivity including mobility, access, or economic development; and

WHEREAS, the United States Department of Transportation administers RCP and has requested applications from eligible agencies for its Cycle 3 call for projects; and

WHEREAS, the City of Fresno is an eligible applicant of the RCP Cycle 3 Call For Projects.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council approves and supports the application for grant funding from the RCP Grant Program for the proposed project and participation therein consistent with constitutional and local law requirements and this resolution.

2. The Council acknowledges that the City has reviewed, understands and to the extent consistent with all constitutional and local law requirements and this resolution
