A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING SUBMISSION OF A FUNDING REQUEST IN THE AMOUNT OF \$2,108,822 TO THE LOW CARBON TRANSIT OPERATIONS PROGRAM FOR THE PURCHASE OF ONE (1) HYDROGEN FUEL CELL ELECTRIC BUS AND OPERATING SUPPORT, EXECUTION OF GRANT AWARD DOCUMENTS IF AWARDED, AND EXECUTION OF RELATED CERTIFICATIONS & ASSURANCES AND AUTHORIZED AGENT FORMS

WHEREAS, the City of Fresno's Department of Transportation (FAX) is an eligible project sponsor and may receive state funding from the Low Carbon Transit Operations Program (LCTOP) for transit projects; and

WHEREAS, applicable statutes related to state-funded transit projects require a local or regional implementing agency to abide by various regulations; and

WHEREAS, Senate Bill 862 (2014) named California Department of Transportation (Caltrans) as the administrative agency for the LCTOP; and

WHEREAS, Caltrans has developed guidelines for the purpose of administering and distributing LCTOP funds to eligible project sponsors (local agencies) and contributing sponsors (Fresno COG) for greenhouse gas reducing projects; and

WHEREAS, FAX wishes to implement the greenhouse gas reducing projects listed in the Certifications and Assurances adopted by Caltrans.

1. FAX is authorized to submit the following greenhouse gas reducing projects nomination and allocation requests to Caltrans in FY 2024-25 LCTOP funds, to specifically benefit local disadvantaged communities:

a. Capital funding to support purchase of a hydrogen fuel cell electric bus (FCEB) - \$1,608,822

b. Operating support to fund system-wide fare subsidies for eligible reduced fare riders - \$500,000

2. The City of Fresno's Director of Transportation or designee is authorized to execute documents related to any resulting funding awards.

3. The City of Fresno's Department of Transportation agrees to comply with all conditions and requirements set forth in the Certifications and Assurances and the Authorized Agent documents and applicable statutes, regulations, and guidelines for all LCTOP funded transit projects.

4. This resolution shall be effective upon final approval.
