

THIRD AMENDMENT TO AGREEMENT

This Third Amendment to Agreement (Amendment) is effective as of _____ (the Effective Date) and amends the Agreement entered into by and between the City of Fresno, a California municipal corporation (the City), and Poverello House, a California nonprofit corporation (Service Provider).

RECITALS

- A. The City and Service Provider entered into an Agreement dated February 9, 2024 (Agreement) to provide Employment Services for youth for compensation not to exceed \$200,000.00.
- B. The City and Service Provider amended the Agreement to revise the effective dates and compensation with the First Amendment (First Amendment) dated August 10, 2024.
- C. The City and Service Provider amended the Agreement with the Second Amendment (Second Amendment) dated June 30, 2025, to revise the effective date to October 31, 2025, and increase total compensation by \$41,630.
- D. The City and Service Provider now desire to amend the Agreement and First and Second Amendment to revise the effective dates of the agreement.
- E. Whereby entry into this Amendment, the Service Provider agrees it has no claim, demand, or dispute against the City.

AGREEMENT

NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual promises herein contained, and for other good and valuable consideration hereby acknowledged, the parties agree that the Agreement be amended as follows:

- 1. **Term of Agreement and Time of Performance.** The Term of Agreement and Time of Performance is hereby amended to continue in full force and effect until December 31, 2025, or until agreed upon compensation is depleted, whichever event occurs first.
- 2. **Effect of Amendment.** In the event of any conflict between the Agreement and this Amendment, this Amendment shall control.
- 3. Except as otherwise provided herein, the Agreement entered into by the City and Service Provider dated February 9, 2024, remains in full force and effect.
