*Councilmember Baines asked Ms. Melendez if the item before Council would help the cause of what Assemblymember Arambula is trying to do and asked Council Vice President Brandau to clarify the title on the record.*

*Councilmember Chavez asked Council Vice President Brandau is he would make changes to the title to read "supporting the operations and maintenance funding of AB3218" or to send a letter outlining what we support or have concerns with. Council Vice President Brandau agreed to the changes to the title and included to deny "the power of eminent domain."*
